

DKR 137/2016 – VARIATION OF FREEZING OF ASSETS

IT IS BEING NOTIFIED that by a decree dated 16th November, 2017 given by the Criminal Court (Madame Justice Dr. Edwina Grima LL.D) after an application filed by Sean Farrugia on the 07th November 2017, Compilation Number 168/2016, in the case:-

The Police
(Inspector Jonathan Cassar)
(Inspector Kurt Zahra)

Versus:

SEAN FARRUGIA, 28 years, self-employed, son of George and Jane nee' Vella, born in Pieta' Malta on the 27th August 1989, residing at 'Springtide', Flat 1, Luigi Onofrio Street, Birkirkara Malta and holder of Maltese Identity Card bearing number 389789(M).

The Court ORDERED the cancellation of the freezing order on the field '*Tal-Barumbara, sive tal-Hadid*' in district of *Sqaq it-Torri sive tal-Qattus*, Birkirkara covering an area of 10,500m² The Court also authorised the contract of partition which will be published by Notary Maria Spiteri and consequently authorise the applicant to appear for the signing of this contract, provided that the applicant's share after this partition will be affected again by the freezing order. Notary Maria Spiteri shall file a note together with a copy of the mentioned contract after it is published.

This variation is being published in terms of Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta following a freezing which decree was given on the 24th March, 2016 by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Josette Demicoli LL.D) and published in the Government Gazette of the 08th April, 2016 whereas the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable property which may be due to or belonging to **Sean Farrugia**.

Il-Qorti ORD NAT illi l-iffriżar tal-assi jitneħħa biss minn fuq l-għalqa msejha 'Tal-Barumbara, sive tal-Hadid' fil-kontrada ta' Sqaq it-Torri sive tal-Qattus, Birkirkara ta' kejl ta' circa 10,500mk. In-Nutar Maria Spiteri permezz ta' nota għandha tipprezenta l-imsemmi kuntratt hekk kif jiġi ppublikat.

Din il-varjazzjoni qed issir ai termini tal-Artikolu 22A tal-Ordinanza dwar il-Medicini Perikolużi, Kap 101 tal-Liġijiet ta' Malta u tal-Artikolu 23A tal-Kodiċi Kriminali, Kap 9 tal-Liġijiet ta' Malta wara ordni ta' ffrizjar mogħtija fl-24 ta' Marzu, 2016 mill-Qorti tal-Maġistrati (Malta) bħala Qorti Istrutturja (Maġistrat Dr. Josette Demicoli LL.D) u li giet ippublikata fil-Gazetta tal-Gvern tat-08 ta' April, 2016 wara li l-Qorti ssekwestrat f'idejn terzi persuni b'mod generali tal-flejjes u l-propjeta' mobbli kollha li jkunu dovuti lill-imsemmi **Sean Farrugia**.
