

DKR 15/2015 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 25th August, 2017 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr. Neville Camilleri LL.D) after an application filed by Sam Zina on the 21st August 2017, Compilation number 839/2014 in the case:

The Police

Versus

SAM ZINA, 22 years, employed, son of Khalil Zina and Carmen Zina Dimech nee' Dimech, born in Pieta' Malta on the 12th August 1995, residing at Block E, Flat 23, *Gilju* Street, Zabbar Malta and holder of Maltese Identity Card bearing number 368195M.

The Court AUTHORISED the accused Sam Zina to open an account in one of the local banks so that the company whom he is employed with can deposit his salary and that he can withdraw the sum of thirteen thousand, nine hundred and seventy-six Euros and twenty-four cents (€13,976.24) from this bank account yearly provided that this sum has not been withdrawn yet for this current year.

This variation is being published in terms of Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and section 23A of the Criminal Code, Chapter 9 of the Laws of Malta following a freezing order dated 20th January, 2015 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dott. Miriam Hayman LL.D.) which was published in the Government Gazette of the 27th January, 2015 where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to **Sam Zina**.

Il-Qorti AWTORIZZAT lill-imputat Sam Zina sabiex jiftah kont bankjarju ma' wiehed mill-banek lokali sabiex il-kumpanija li hu mpjegat magħha tibda tiddepożita l-paga tiegħu fih u wkoll sabiex ikun jista' jirtira s-somma ta' tlettax-il elf, disa' mija u sebgha u sittin Ewro u erbgha u ghoxrin ċenteżmu (€13,976.24) fis-sena mill-istess kont u dment li għas-sena kurrenti dan l-ammont għadu ma ġiex migbud.
