STEPHEN PORTELLI, 39 years, employed, son of Carmelo and Carmen nee' Mangion, born in Pieta' Malta on the 19th October 1977, residing at number 30, Main Street, Tarxien Malta and holder of Maltese Identity Card bearing number 541877M.

The Court AUTHORISED the release of the open boat named White Sand with registration number S 9809 in favour of Anthony Meachen Identity Card number 313680M.

This variation is being published following a freezing order given by the same Court on the 12th April, 2015 which was duly published in the Government Gazette on the 21st April, 2015 in terms of Section 22A of the Dangerous Drugs Ordinance , Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta where the Court ordered the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **Stephen Portelli**.
