**The Court REVOKED the freezing order imposed on the late Guiseppe Cutajar and** authorized the release of all the assets belonging to the *decujus* in favour of the said Susan Callus.

The publication of this order is being published in terms of Section 5 of the Prevention of Money Laundering Act Chapter 373 of the Laws of Malta, and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta, following a freezing order which was published in the Government Gazette of the 18<sup>th</sup> May 2012 after a decree from the Court of Magistrates (Malta) as a Court of Criminal Inquiry on the 16<sup>th</sup> May 2012 where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to Sharon Camilleri and **Giuseppe Cutajar.**
