

## DKR 178/2016 – VARIATION OF A FREEZING ORDER

**IT IS BEING NOTIFIED** that by a decree dated 18<sup>th</sup> January, 2017 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Neville Camilleri LL.D) after an application filed by Johan Borg on the 19<sup>th</sup> September 2016, Compilation number 316/2016 in the case:

**The Court AUTHORISED the accused Johan Borg** to deposit the monthly payments on the home loan account number 2000150320-4 with APS bank and **also** to cash his salary cheque or to withdraw the said salary from the bank account number 2000132829-3 with the same bank.

This variation is being published in terms of Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta, following a freezing order given on the 19<sup>th</sup> June, 2016 by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr. Claire Stafrace Zammit LL.D) and published in the Government Gazette on the 24<sup>th</sup> June, 2016 whereas the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable property which may be due to or belonging to **Johan Borg and Clint Joseph Muscat**.
