

DKR 20/2017 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 06th April, 2017 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Neville Camilleri LL.D) after an application filed by Paolo Santaro on behalf of Oramec dei Fratelli Santoro snc on 04th April 2017, Compilation number 60/2017 in the case:

MARCO FEDE, 28 years, unemployed, son of Orazio and Carmela nee' Accolla, born in Siracusa, Sicily on the 12th May 1988, with no address in Malta and holder of Italian Identity Card bearing number AX 5322165;

FRANCESCO MICCA, 39 years, self-employed, son of the late Pietro and Concettina nee' Montalto, born in Siracusa, Sicily on the 09th January 1978, with no address in Malta and holder of Italian Identity Card bearing number AS 4774134; AND

SARAH TUCCITTO, 25 years, unemployed, daughter of Paolo and Sebastiana nee' Saccuzzio, born in Siracusa, Sicily on the 11th October 1991, with no address in Malta and holder of Italian Identity Card bearing number AS 4773833.

The Court AUTHORISED the release of the vehicle Fiat 500 with license plate D2103VD in favour of the above mentioned society which car was exhibited in the acts of these proceedings.

This variation is being published following a freezing order given by the same Court on the 03rd February, 2017 in terms of Section 22A of the Dangerous Drugs Ordinance , Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta where the Court ordered the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **Marco Fede, Francesco Micca and Sarah Tuccitto**.
