

**DKR 20/2017 – NEW FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 03<sup>rd</sup> February, 2017 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Aaron M. Bugeja LL.D) Compilation number 60/2017 in the case:

Versus

**MARCO FEDE**, 28 years, unemployed, son of Orazio and Carmela nee' Accolla, born in Siracusa, Sicily on the 12<sup>th</sup> May 1988, with no address in Malta and holder of Italian Identity Card bearing number AX 5322165;

**FRANCESCO MICCA**, 39 years, self-employed, son of the late Pietro and Concettina nee' Montalto, born in Siracusa, Sicily on the 09<sup>th</sup> January 1978, with no address in Malta and holder of Italian Identity Card bearing number AS 4774134; AND

**SARAH TUCCITTO**, 25 years, unemployed, daughter of Paolo and Sebastiana nee' Saccuzzio, born in Siracusa, Sicily on the 11<sup>th</sup> October 1991, with no address in Malta and holder of Italian Identity Card bearing number AS 4773833.

**ORDERED** the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **MARCO FEDE**, **FRANCESCO MICCA** and **SARAH TUCCITTO** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

Any person who acts in contravention of the court order mentioned in Section 22A referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand and six hundred and forty-six euro and eighty-seven cents (11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any immovable property made in contravention of the said court order shall be null and without effect at law.
