

DKR 219/2016 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 13th January, 2017 given by the Criminal Court (Malta) - (Mrs Justice Edwina Grima LL.D) after an application filed by Jeffrey Micallef on the 03rd January 2017, Compilation number 366/2016 in the case:

Versus

JEFFREY MICALLEF, 32 years, employee, son of Saviour and Gemma nee' Mifsud, born in Pieta' Malta on the 11th August 1984, residing at number 21, Destiny Court, Block C, Flat 2, Lorry Sant Street, Fgura Malta and holder of Maltese Identity Card bearing number 398684(M).

The Court AUTHORISED the accused Jeffrey Micallef to withdraw from his salary the amount of thirteen thousand nine hundred and seventy Euro and twenty cents (€ 13,976.24) and authorised his employer that for this year 2017, to forward him this amount. The accused is not authorised to withdraw other amounts from any other earnings he can perceive.

This variation is being published in terms of Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta, following another variation which decree was given on the 19th December, 2016 and following a freezing order given on the 15th July, 2016 by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr. Charmaine Galea LL.D) and published in the Government Gazette on the 09th August, 2016 whereas the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable property which may be due to or belonging to **Jeffrey Micallef**.
