

DKR 225/2012 – CANCELLATION OF A FREEZING ORDER

The Court ORDERED THE CANCELLATION of the freezing order of all the assets of the said **Lin Han** which order was given by the Criminal Court (Malta) by a decree dated 08th August, 2012 and published in the Government Gazette of the 10th August, 2012.
