

## **DKR 236/2010 – VARIATION OF A FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 07<sup>th</sup> February, 2017 given by the Criminal Court of Appeal - (Mr. Justice David Scicluna) after an application filed by Alexander Scudamore on the 28<sup>th</sup> November, 2016 and following judgement given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr. Doreen Clarke, LL.D.) on the 05<sup>th</sup> June, 2012 in the case:

The Police  
(Supt. Ian Joseph Abdilla)

versus:

**ALEXANDER SCUDAMORE**, 53 years, son of Alexander and Josephine nee' La Rosa, born in Lambeth, England on the 15<sup>th</sup> October 1963, residing at number 18, Flat 1, L. Graham Street, Sliema Malta and holder of Identity Card bearing number 458986(M).

**THE COURT ORDERED** that the freezing order issued on the 16<sup>th</sup> June, 2010 is applicable only on the property pertaining to the appellant till the 7<sup>th</sup> February 2017 and not on any other property that Alexander Scudamore acquires after the 7<sup>th</sup> February 2017.

This variation is being published in terms of Section 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta and Section 23A(2) of the Criminal Code, Chapter 9 of the Laws of Malta, following another decree given on the 06<sup>th</sup> March 2012 by the Court of Magistrates as a Court of Criminal Inquiry (Mag.Dr. Doreen Clarke), following another decree given on the 18<sup>th</sup> January 2012 by the same Court and following a freezing order given on the 16<sup>th</sup> June 2010 by the same Court, whereas the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable property which may be due to or belonging to **Alexander Scudamore**.
