

DKR 236/2017 – NEW FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 20th June, 2017 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Donatella Frendo Dimech) Compilation number 269/2017 in the case:

(Inspector Kevin Pulis)

Versus

CARINE ROSE-MARIJKE DONCKERS, 51 years, Self-Employed, wife of Johnny Jos Haest, daughter of Leo and Marciette nee' De Smet, born in Belgium on the 22nd December 1965, without a fixed address in Malta and holder of Belgian Identity Card number 592-1332074-54;

AND

JOHNNY JOS HAEST, 46 years, Self-Employed, son of the late Harry and Arlette nee' Bols, born in Belgium on the 30th October 1971, without a fixed address in Malta and holder of Belgian Identity Card number 592-1332059-39.

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **CARINE ROSE-MARIJKE DONCKERS** and **JOHNNY JOS HAEST** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

Any person who acts in contravention of the court order mentioned in Section 22A referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand and six hundred and forty-six euro and eighty-seven cents (11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any immovable property made in contravention of the said Court order shall be null and without effect at law.
