

## DKR 240/2014 – VARIATION OF A FREEZING ORDER

**IT IS BEING NOTIFIED** that by a decree dated 31<sup>st</sup> October, 2017 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Neville Camilleri LL.D) after an application filed by Angelo Zahra on the 13<sup>th</sup> October 2017, Compilation Number 427/2001 in the case:

Versus:

**ANGELO ZAHRA**, 68 years, pensioner, son of the late Joseph and Grazia nee' Zammit, born in Santa Venera Malta on the 29<sup>th</sup> August 1949, residing at 'Shekinah', *Bidnija* Road, *Bidnija* Malta and holder of Maltese Identity Card bearing number 751849(M).

**The Court AUTHORISED the Commissioner of Lands** to pay the accused Angelo Zahra the sum of thirty-four thousand, one hundred and eighty-seven Euros (€34,187) besides the legal interest and court costs so that the judgement given from the Court of Appeal dated 26<sup>th</sup> May, 2017 is executed and that the same accused is finally compensated for the piece of land he bought in the year 1981 which was expropriated from him.
