

## DKR 254/2014 – VARIATION OF A FREEZING ORDER

**IT IS BEING NOTIFIED** that by a decree dated 27<sup>th</sup> June, 2017 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry - (Magistrate Dr. Neville Camilleri LL.D) after an application filed by Rosario Militello on the 12<sup>th</sup> May 2017, Compilation number 714/2014 in the case:

**ROSARIO MILITELLO**, 36 years, son of Francesco and Agatina nee' Piacenti, born in Catania, Sicily on the 26<sup>th</sup> August 1980, residing at number 71, Flat 1A, *Mensija* Street, St. Julians Malta and holder of Italian passport YA3484904.

**The Court AUTHORISED the accused Rosario Militello** to withdraw the amount of thirteen thousand nine hundred and seventy Euro and twenty cents (€ 13,976.24) every year from his bank account bearing number 4002155740-8 with Bank of Valletta.

This variation is being published in terms of Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta following a freezing order given on the 05<sup>th</sup> August, 2014 by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr. Natasha Galea Sciberras LL.D) and published in the Government Gazette of the 19<sup>th</sup> August, 2014 whereas the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable property which may be due to or belonging to **Rosario Militello**.
