This variation is being published in terms of Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta following a freezing order dated 29th December, 2008 which was duly published in the Government Gazette of the 2nd of January, 2009 by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr. Doreen Clarke LL.D) whereas the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable property which may be due to or belonging to **Rupert Azzopardi, Carmelo Borg, Marvin Debono and Paul Azzopardi.**
