

**DKR 275/2016 – VARIATION OF A FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 01<sup>st</sup> February, 2017 given by the Criminal Court (Malta) - (Mr Justice Antonio Mizzi LL.D) after an application filed by Joseph Rodney Grima on the 27<sup>th</sup> January 2017, Compilation number 450/2016 in the case:

Versus

**JOSEPH RODNEY GRIMA**, 23 years, in construction, son of Taddeo and Pauline nee' Mizzi, born in Rabat Gozo on the 5<sup>th</sup> October 1992, residing at Emerald, *Borg Għarib* Street, Ghajnsielem Gozo and holder of Maltese Identity Card bearing number 37092G.

**The Court AUTHORISED the accused Joseph Rodney Grima or his parents Taddeo and Pauline Grima** to continue to pay the remaining balance on the motor loan account with Bank of Valletta and the said bank shall receive these payments.

This variation is being published in terms of Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta, following a freezing order given on the 24<sup>th</sup> August, 2016 by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr. Antonio Micallef Trigona LL.D) and published in the Government Gazette on the 26<sup>th</sup> August, 2016 whereas the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable property which may be due to or belonging to **Joseph Rodney Grima**.
