

DKR 32/2004 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 16th June, 2017 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr. Audrey Demicoli LL.D) after an application filed by Giovanna Pace on the 13th June, 2017 (Drugs Number 325/2004) in the case:

Versus:

GIOVANNA PACE, 66 years, daughter of Michael Azzopardi and Frances nee' Falzon, born in Qormi Malta on the 12th December 1950, residing at number 61, Mill Street, Qormi Malta and holder of Maltese Identity Card bearing number 27551(M);

AND

OMISSIS

The Court AUTHORISED the accused Giovanna Pace to have a hypothec registered in her name in favour of the Government of Malta where the Revisory Committee Board acceded to the request of a stairlift installation under the scheme of 'Persons with Disability'.

This variation is made following a freezing order dated 22nd April, 2004 and published in the Government Gazette of the 01st June, 2004 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry and this in terms of Section 22A (1)(a)(b) of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to **Giovanna Pace, Mark Pace, Joseph Pace and Christopher Mazzitelli**.
