

DKR 34/2011 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 13th January 2017, given by the Criminal Court – (Mrs Justice Edwina Grima LL.D.) after an application filed by George Frendo on the 03rd January 2017, Compilation Number 370/2011 in the case:

AND

GEORGE FRENDO, 51 years, son of Alfred and Carmela nee' Camilleri, born in Marsa Malta on the 29th June 1965, residing at number 6, Rose Street, Żurrieq Malta and holder of Maltese Identity Card bearing number 361665(M).

The Court AUTHORISED the accused George Frendo to receive from his income the sum of thirteen thousand nine hundred and seventy Euro and twenty cents (€ 13,976.24), provided that, when he withdraws this sum he has to present a note in the acts of the case together with the relative documents to show that the sum had been withdrawn for this current year, that is 2017.

This variation is being published in terms of Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta, after a decree given by the Court of Magistrates (Malta) as Court of Criminal Inquiry (Magistrate Dr. Giovanni Grixti LL.D.) on the 03rd March, 2011 and published in the Government Gazette on the 08th March, 2011 where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to **Paschalino Cefai and George Frendo**.
