IT IS BEING NOTIFIED that by a decree dated 21st March, 2017 given by the Court of Magistrates as a Court of Criminal Inquiry (Magistrate Dr. Antonio Micallef Trigona LL.D) after an application filed by Jason Caruana on the 09th March 2017, Compilation number 1417/2007 in the case:

The Court ACCEDED to the request of the accused Jason Caruana that the vehicle under registration number TFD which he is going to acquire with the help of his family and the Community Chest Fund due to his physical disability, will not be affected by the freezing order .

The publication of this order is being published in terms of Section 23A (2) of the Criminal Code, Chapter 9 of the Laws of Malta, following another publication which decree was given on the 27th October 2016 from the same Court, following another publication which decree was given on the 04th July 2014 given by the Criminal Court and published in the Government Gazette on the 12th August, 2014 and following a freezing order which decree was given on the 18th November, 2007 by the Court of Magistrates as a Court of Criminal Inquiry and published in the Government Gazette on the 20th November, 2007 where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to Samuel Ritchie, Carol Mangion and **Jason Caruana**.
