

DKR 425/2014 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 30th March, 2017 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Neville Camilleri LL.D) after an application filed by Erika Vella on the 28th March, 2017 (Compilation number 819/2014) in the case:

Versus

ERIKA VELLA, 30 years, unemployed, daughter of Mario and Rita nee' Zahra, born in Pieta' Malta on the 27th September 1986, residing at *Redentur, Gudja Street, Ghaxaq* Malta and holder of Maltese Identity Card bearing number 438186M.

The Court **AUTHORIZED Erika Vella** to withdraw the sum of six hundred and seventy-six Euros and eleven cents (€676.11) from her bank account with APS bearing number 2000151420-2 which sum has to make part of the sum of thirteen thousand nine hundred and seventy-six Euros and twenty-four cents (€13,976.24) which is entitled to her every year.

This variation was made following another variation which was published on the 16th February, 2016 after a decree given on the 27th January, 2016 by the Court of Magistrates (Malta) as a Court of Criminal Inquiry, following another variation which was published on the 10th of November, 2015 after a decree given on the 08th of October, 2015 from the Criminal Court, following another variation which was published on the 06th of February, 2015 after a decree given on the 28th January, 2015 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry and following a freezing order dated 26th November, 2014 which was duly published in the Government Gazette on the 05th of December, 2014 in terms of Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta where the Court ordered the attachment in the hands of third parties in general all monies and other movable property belonging to **Erika Vella**.
