

DKR 427/2017 – NEW FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 17th October, 2017 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Neville Camilleri LL.D) Compilation number 448/2015 in the case:

The Police
(Inspector Malcolm Bondin)

Versus

SIMON DOUGLAS ROBERTS, 31 years, employed, son of Douglas and Michelle nee' Bezzina, born in Bangor, England on the 01st May 1986, residing at Victoria Appartments, Flat 3, *Masar Street, Burmarrad*, Malta and holder of English Passport bearing number GBR 207453405.

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **SIMON DOUGLAS ROBERTS** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court AUTHORISED the accused **Simon Douglas Roberts** to receive the amount authorized by law which is thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) on an annual basis.

Any person who acts in contravention of the court order mentioned in Section 22A referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand and six hundred and forty-six euro and eighty-seven cents (11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any immovable property made in contravention of the said Court order shall be null and without effect at law.
