

DKR 64/2016 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 23rd May, 2017 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Neville Camilleri LL.D) after an application filed by Kevin Joseph Zerafa on the 08th May 2017, Compilation number 110/2016 in the case:

Versus

LUKE VELLA

AND

RENNIE FAVA

AND

KEVIN JOSEPH ZERAFKA, 32 years, works in Construction, son of Saviour and Helen nee' Brincat, born in Pieta' Malta on the 03rd June 1984, residing at San Spiridione Farmhouse, *Gardiel* Street, Marsaskala Malta and holder of Maltese Identity Card bearing number 290584M.

The Court AUTHORISED the accused Kevin Joseph Zerafa to appear on the final contract of sale regarding the property with number 45, previously number 47, in Freedom Street, previously Brittanica Street sive' Britannia Street in Żejtun. **The Court ordered also** that the proceeds of this sale pertaining to Kevin Joseph Zerafa are deposited by means of a schedule of deposit in the Court Registry.

This variation is being published in terms of Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta, following a freezing order given on the 29th February, 2016 by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr. Audrey Demicoli LL.D) and published in the Government Gazette of the 04th March, 2016 whereas the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable property which may be due to or belonging to **Luke Vella, Rennie Fava and Kevin Joseph Zerafa.**
