

**DKR 85/2017 – NEW FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 20<sup>th</sup> March, 2017 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Consuelo Scerri Herrera LL.D) Compilation number 131/2017 in the case:

The Police  
(Inspector Malcolm Bondin)

Versus

**PATRYK HENRYK STAWICKI**, 23 years, unemployed, son of Dawid and Renata, born in Mielec, Poland on the 03<sup>rd</sup> September 1993, with no address in Malta and holder of Polish Identity Card bearing number AUD690099.

**ORDERED** the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **PATRYK HENRYK STAWICKI** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

Any person who acts in contravention of the court order mentioned in Section 22A referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand and six hundred and forty-six euro and eighty-seven cents (11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any immovable property made in contravention of the said court order shall be null and without effect at law.
