

DKR 9/2014 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 07th February, 2017 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Neville Camilleri LL.D) after an application filed by Brian Godfrey Bartolo on the 31st May 2016, Compilation number 51/2014 in the case:

The Police
(Inspector Malcolm Bondin)

Versus:

BRIAN GODFREY BARTOLO, 44 years, son of John and Carmen nee' Cilia, born in Pietà Malta on the 30th August 1972, residing at number 97, Alimatta Flat 2, Valley Road, Mosta Malta and holder of Maltese Identity Card bearing number 372972(M).

The Court AUTHORISED the accused Brian Godfrey Bartolo to continue to receive his his payments for a decent living to the amount of **eleven thousand six hundred and sixty four Euros and thirty-two cents (€11,664.32)** yearly from his e-savings account bearing number 40016473018 with Bank of Valletta which account belongs to the accused **Brian Godfrey Bartolo**. This amount is the balance from the amount authorized by law which is thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) from which the amount of two thousand three hundred and eleven Euros and ninety-two cents (€2,311.92) is the amount being received by his wife for social benefits.

The publication of this order is being published in terms of Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta. This follows a publication made on the 19th August 2014 after a decree by the same court on the 16th July 2014, following another publication made on the 15th July 2014 after a decree by the same court on the 25th June 2014, following another publication made on the 21st January 2014 after a decree of the same Court on the 13th January 2014, where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to Brian Godfrey Bartolo.
