

## DKR 9/2017 – VARIATION OF A FREEZING ORDER

**IT IS BEING NOTIFIED** that by a decree dated 04<sup>th</sup> January, 2017 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr. Neville Camilleri LL.D) after an application filed by Robert Agius on the 03<sup>rd</sup> January 2017, Compilation number 500/2012 in the case:

**ROBERT AGIUS**, 33 years, son of Raymond and Paola nee' Zammit, born in Pieta' Malta on the 29<sup>th</sup> October 1983, residing at Olive Court, Block B, Penthouse 11, *Baħħara* Street, St. Paul's Bay, Malta and holder of Maltese Identity Card bearing number 569383(M).

**The Court AUTHORISED the accused Robert Agius** to receive his salary to the amount authorised by law which is thirteen thousand nine hundred and seventy Euro and twenty cents (€ 13,976.24) yearly.

This variation is made following a freezing order dated 11<sup>th</sup> May, 2012 in terms Section 22A (1)(a)(b) of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to **Robert Agius**.
