

DKR 9/2017 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 14th June, 2017 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr. Neville Camilleri LL.D) after an application filed by Robert Agius on the 03rd March 2017, Compilation number 500/2012 in the case:

Versus:

ROBERT AGIUS, 33 years, son of Raymond and Paola nee' Zammit, born in Pieta' Malta on the 29th October 1983, residing at Olive Court, Block B, Penthouse 11, *Baħħara* Street, St. Paul's Bay, Malta and holder of Maltese Identity Card bearing number 569383(M).

The Court AUTHORISED Pauline Agius (the mother of the accused Robert Agius) holder of Identity Card number 484858(M) as the settlor of Oyster Trust with Bank of Valletta plc to continue to pay the loan in the mentioned trust.

This variation is made following another variation published on the 27th January, 2017 which decree was given on the 04th January, 2017 and following a freezing order dated 11th May, 2012 and published in the Government Gazette of the 20th January, 2017 and this in terms of Section 22A (1)(a)(b) of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to **Robert Agius**.
