

DKR 9/2017 – NEW FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 11th May, 2012 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Francesco Depasquale LL.D) Compilation number 500/2012 in the case:

The Police
(Inspector Pierre Grech)

Versus

ROBERT AGIUS, 33 years, son of Raymond and Paola nee' Zammit, born in Pieta' Malta on the 29th October 1983, residing at Olive Court, Block B, Penthouse 11, *Baħħara* Street, St. Paul's Bay, Malta and holder of Maltese Identity Card bearing number 569383(M).

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **ROBERT AGIUS** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Section 22A (1)(a)(b) of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court AUTHORISED the accused **Robert Agius** to receive the amount authorized by law which is thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year.

Any person who acts in contravention of the court order mentioned in Section 22A referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand and six hundred and forty-six euro and eighty-seven cents (11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any immovable property made in contravention of the said Court order shall be null and without effect at law.

The Registrar of Court was notified with this decree on Friday 13th January, 2017.
