

DKR 19/2011 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 09th October 2017, given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr. Neville Camilleri LL.D.) after an application filed by Kevin Tanti on the 05th October 2017, Compilation Number 252/2011 in the case:

KEVIN TANTI, 41 years, Employer, son of Anthony and the late Lilian nee' Sawyer, born in Pieta' Malta on the 9th November 1975, residing at number 49, *Telgħet Birkirkara*, St. Julians Malta and holder of Maltese Identity card number 562075(M).

The Court AUTHORISED the accused Kevin Tanti to renew the car licence and the insurance of the vehicle with registration number ABH-546 which car will remain affected by the freezing order.

This variation is being published in terms of Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta following a freezing order given by the Court of Magistrates (Malta) as Court of Criminal Inquiry (Magistrate Dr. Consuelo Scerri Herrera LL.D) on the 02nd February 2011 and published in the Government Gazette of the 04th February 2011, where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to Anthony Tanti and **Kevin Tanti**.
