

DKR 332/2014 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 05th January, 2017 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Neville Camilleri LL.D.) after an application filed by Aldo Pistella on the 03rd January 2017, Compilation number 1010/2014 in the case:

Versus:

ALDO PISTELLA, 38 years, employed, son of Franco Pistella and Aurora nee' Milioto, born in Favara Sicily, on the 05th September 1978, residing at 51, Penthouse, Clover Street, Marsascala, Malta and holder of Identity Card number 52161A.

The Court AUTHORISED the accused Aldo Pistella to receive his salary within the amount permitted to him by law that is thirteen thousand nine hundred and seventy Euro and twenty cents (€ 13,976.24) every year.

This variation is made following another two decrees dated 21st March, 2016 and 28th June, 2016 and published in the Government Gazette on 09th, August 2016 and following a freezing order dated 18th October, 2014 which was duly published in the Government Gazette on the 04th November, 2014 in terms of Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to **Aldo Pistella**.
