## DKR 498/2015 – VARIATION OF A FREEZING ORDER

**IT IS BEING NOTIFIED** that by a decree dated 28<sup>th</sup> June 2017 given by the Court of Magistrates (Gozo) as a Court of Criminal Inquiry - (Magistrate Dr. Joseph Mifsud B.A., (Leg. & Int. Rel.) B.A. (Hons.) M.A. (European), LL.D) following an application filed by the accused Jonathan Roger Portelli on the 26th June 2017, Preliminary Investigation number 112/2013 in the case:

Versus

**JONATHAN ROGER PORTELLI**, 34 years of age, son of Roger and of Antoinette née Debrincat, born in Victoria, Gozo on the 3rd May 1982 and residing at Highfields, Ta' Luvier Street, Munxar, Gozo and holder of Maltese Identity Card bearing number 32782G.

**The Court AUTHORISED the accused Jonathan Roger Portelli to purchase a motorcycle of the make Honda, model NSC110, and to register same in his name**, so however that it be registered in the compendium of assets in the name of the accused so that in case of guilt, it would be subject to confiscation.

This variation is being published in terms of Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta, following a freezing order given on the 30<sup>th</sup> September 2015 by the Court of Magistrates (Gozo) as a Court of Criminal Inquiry (Magistrate Dr. Joseph Mifsud B.A., (Leg. & Int. Rel.) B.A. (Hons.) M.A. (European), LL.D) and published in the Government Gazette on the 6<sup>th</sup> October 2015 whereas the Court *inter alia* ordered the attachment in the hands of third parties in a general manner, all monies and other movable property which may be due to or belonging to said **Jonathan Roger Portelli**.
