**ANTHONY PACE**, 43 years, Enemalta employee, son of Attilio and Dolores nee' Azzopardi, born in Attard, on the 31<sup>st</sup> October 1970 and residing at 36, 'Chez Carelle', Madre Tereza Street, Mosta and holder of identity card bearing number 455070M;

**ORDERED** the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **Anthony Pace** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the said accused may continue to receive an amount which will not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year in terms of Article 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta.
