

IT IS BEING NOTIFIED that by a decree dated 3rd April, 2013 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dott. Antonio Micallef Trigona LL.D., Compilation number 300/2013 in the case:

Versus:

Joseph Grech, 45 years, son of Carmelo and Maria Stella nee' Muscat, born in Marsa on the 2nd October 1967, residing at 13, Triq ix-Xemxija, Marsa and holder of Identity card number 423567(M);

ORDERED the attachment in the hands of third parties in general all monies and other moveable property due or pertaining or belonging to **Joseph Grech** and prohibits the said accused from transferring or otherwise disposing of any moveable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, Section 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta and section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the said accused may receive an amount which does not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year.
