MARTIN CILIA LACORTE, 49 years, maintenance employee with the Government, son of Alfred and Doris nee' Borg, born in Pietà on the 9th May 1964 and residing at 'Marson', Il-Qaliet Street, Marsascula and holder of identity card bearing number 249964M;

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **Martin Cilia Lacorte** and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Article 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta and to Article 23A(2) of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the said accused may receive thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year.
