IT IS BEING NOTIFIED that by a decree given by the Criminal Court-Judge Michael Mallia LL.D. on the 4th September 2014 following an application filed by Emanuel Bajada on the 25th August 2014, Court Case Number 992/2005 – in the names The Police (Police Inspector Paul Vassallo) versus:

Emanuel Bajada, 61 years old, son of Carmelo and Carmela nee' Zammit born in Hamrun on the 20th December, 1953, and residing at Manor Court, Block F, Flat 4, Tourists Street, Qawra, Holder of I.D. Card No. 70054(M);

Varied the freezing order **only** with respect to the revocation of the freezing order on all movable and immovable property of **Emanuel Bajada** that is owned or is in his possession or control **after** the date of the judgement of the Court of Criminal Appeal that is of the 24th September 2009, and also as stated in the judgment of the Court of Appeal dated 28th March 2014 with reference to '*Adams Guest House*', Ross Street, St. Julian's and the contents of safe deposit box number 37B held in Bank of Valletta.

This publication is being made after another erroneous publication dated 31st October 2014 as the contents hereby stated should be followed.

The freezing of all assets was ordered by the Court of Magistrates (Malta) in the above mentioned case on the 7th September, 2006, and was duly published in the Government Gazette on the 22nd September, 2006;
