ALNAFOURI MOHAMAD NOUR, 19 years, Footballer, son of Radnour and Kalat, born in Syria on the 23rd March 1994 and residing at Flat No: 1, Block 36, Mayfair Court, Gejza Street, Swieqi, and holder of Maltese Identity Card bearing number 59715(A);

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **Alnafouri Mohamad Nour** and prohibits the said accused from transferring or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the said accused may continue to receive an amount which will not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year.
