**ACCEDED** to the request of **Renald Attard** in the sense that the Court authorized the accused to start receiving the permissible annual sum of thirteen thousand nine hundred seventy six Euro and twenty four cents (€13,976.24).

**ORDERED** the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **Renald Attard** and prohibits the said accused from transferring or otherwise disposing of any movable or immovable property and this according to Article 22A of Dangerous Drugs Ordinance Chapter 101 of the Laws of Malta, of Article 5 (1) (a) (b) and 5(1) and 5(2) of the Money Laundering Act, Chapter 373 of the Laws of Malta and of Article 23A, and of the Criminal Code Chapter 9 of the Laws of Malta.
