Versus:

ANGEL ATTARD, 32 years, Plasterer, son of Raymond and Carmen nee' Azzopardi, born in Pieta on the 21st October, 1981, and residing at Savoy Gardens Block J, Flat 20, D'Argens Street, Gzira and holder of Maltese Identity Card bearing number 632281(M).

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **Angel Attard** and prohibits the said accused from transferring or otherwise disposing of any movable or immovable property and this according to Article 22A of Dangerous Drugs Ordinance Chapter 101 of the Laws of Malta, of Article 5 (1) (a) (b) and 5(2) of the Money Laundering Act, Chapter 373 of the Laws of Malta and of Article 23A, of the Criminal Code Chapter 9 of the Laws of Malta.

The accused **Angel Attard** can **only** withdraw the sum of thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) yearly as established by the law.
