ORDERED the attachment in the hands of third parties in general all monies and other moveable property due or pertaining or belonging to **Ola Rotimi Akins and Edward Cardona** and prohibits the said accused from transferring or otherwise disposing of any moveable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the said accused may continue to receive any salary, wages, pension or other social security benefits in the amount which will not exceed twelve thousand, nine hundred and sixty seven euro and twenty four cents (€12, 967.24) per year.
