

IT IS BEING NOTIFIED that by a decree dated 5th October, 2014 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Miriam Hayman LL.D.) Compilation number 972/2014 in the case:

Versus:

AKRAM AMMAR SWAYAH, 37 years, plasterer, son of Ammar and Munira nee' Binresir, born in Tripoli, Libya on the 5th December 1976 and residing at Meridien Court, Flat 4A St Paul's Street, St Paul's Bay. Passport number/ Identity Card number not available.

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **Akram Ammar Swayah**, and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Article 22 of the Dangerous Drugs Act Chapter 101 of the Laws of Malta and of Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court authorizes the accused **Akram Ammar Swayah** to start receiving the permissible monthly sum up to thirteen thousand six hundred and eighty five (€13,685) yearly. Furthermore the same Court has to be informed by a decree or note form which bank or any other source the accused will retrieve this sum.
