TREVOR BORG, 30 years, unemployed, son of Saviour and Rita nee' Gatt, born in Pieta', on the 1st October 1983 and residing at 57, Fuq il-Verdala, Bormla and holder of Maltese identity card bearing number 508983M;

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **TREVOR BORG** and prohibits the said accused from transferring or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court authorized the said accused to receive thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year and before such monies is withdrawn, the Court should be informed my means of a note accordingly.
