ROSARIO CARUSO, 40 years, poker player, son of Salvatore and Giovanna nee' Grasso, born in Catania, on the 16th of April 1973 and residing at Pender Gardens, Number 1102, Sant'Andrija Street, St Julians and/or Via Bartolomeo Altavilla, Number 18, Catania and holder of Italian passport number AA1055886;

ORDERED the attachment in the hands of third parties in general all monies and other moveable property due or pertaining or belonging to **Rosario Caruso** and prohibits the said accused from transferring or otherwise disposing of any moveable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the said accused may continue to receive an amount which will not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year.
