

IT IS BEING NOTIFIED that by a decree dated 13th February 2014, given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr. Carol Peralta LL.D) after an application filed by Brian Buttigieg and Joanne Cutajar on the 9th December 2013, Compilation Number 417/2013 in the case:

JOANNE CUTAJAR, 30 years, housewife, daughter of Consiglio and Josephine nee' Mallia, born in Pietà on the 19th September 1983 and residing at 'Mandalay Court', Flat 3, Haż-Żebbuġ Street, Attard and holder of Identity Card bearing number 472383(M);

ACCEDED to the request of **Brian Buttigieg and Joanne Cutajar** in the sense that the Court authorized Bank of Valletta plc to receive payments of € 473.17 per month from the accused in the loan account bearing number 400 2055 1573. Moreover, the Court also authorized Bank of Valletta plc to allow Brian Buttigieg to withdraw the sum of € 700 from his savings account bearing number 138 1694 4017.

The publication of this order is being published in terms of Section 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta following another publication made on the 22nd November 2013 after a decree of the same Court on the 14th November 2013 whereas the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to **Brian Buttigieg and Joanne Cutajar**.
