ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **Brian Buttigieg and Joanne Cutajar** and prohibits the said accused from transferring or otherwise disposing of any movable or immovable property and this according to Section 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta, and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the said accused may continue to receive an amount which will not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year.
