**ORDERED** the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **John Camilleri and Antonia Camilleri** and prohibits the said accused from transferring or otherwise disposing of any movable or immovable property and this according to Section 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta, and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the accused John Camilleri may continue to receive his pension issued by the Department of Social Security and bearing number 10/03 12024, which amount may not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year. Moreover, the Court ordered that the accused Antonia Camilleri may continue to receive her contributory pension issued by the Department of Social Security, which amount may not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€ 13,976.24) per year.
