

IT IS BEING NOTIFIED that by a decree dated 11th December 2013 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Miriam Hayman LL.D) Compilation number 545/2013 in the case:

Versus:

BASHIR ALI MOHAMED ESGAYEIR, 33 years, unemployed, son of Ali and Kadisha Moktar, born in Libya, on the 14th August 1980 and residing in Zawia, Libya and at Sliema Hotel, Malta and holder of Libyan passport bearing number 648419;

AND

NABIL FARHAT A. KOUJA, 33 years, unemployed, son of Farhat and Hawa nee' Tanko, born in Tripoli, Libya, on the 10th May 1980 and residing in Tripoli, Libya and at Sliema Hotel, Malta and holder of Libyan passport bearing number 912044;

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **Bashir Ali Mohamed Esgayeir and Nabil Farhat A. Kouja** and prohibits the said accused from transferring or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the said accused may continue to receive an amount which will not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year. Moreover, the Court ordered that it must be informed of each withdrawal that the accused will be making.
