Architecture Limited**, having registration number C 30595.

ACCEDED to the request of **Gernot Knoess** in the sense that the Court authorised the accused to withdraw the amount of thirteen thousand, nine hundred and seventy-six euro and twenty four cents (€13,976.24) annually to be withdrawn from the company account number at Bank of Valletta as indicated in the court verbal.

The publication of this order is being published in terms in terms of Section 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta and Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta following a publication made on the 14th February 2012 after a decree of the same Court on the 8th February, 2012 where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to **Gernot Knoess**.
