

IT IS BEING NOTIFIED that by a decree dated 22nd October, 2013, given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Claire L. Stafrace Zammit LL.D) after an application filed by Vincenza *sive* Vivienne Mifsud and Tarċisju Mifsud dated 23rd September 2013 and after an application filed by Mediterranean Insurance Brokers (Malta) Limited dated 10th October 2013, Compilation Number 191/2013 in the names:

ACCEDED to the request of **Vincenza *sive* Vivienne Mifsud and Tarċisju Mifsud and also of Mediterranean Insurance Brokers (Malta) Limited** in the sense that Mediterranean Insurance Brokers (Malta) Limited is authorized to pay the sum of four hundred Euro (€ 400) to Vincenza *sive* Vivienne Mifsud, which sum arises from a claim made by Vincenza *sive* Vivienne Mifsud and Tarċisju Mifsud to Mediterranean Insurance Brokers (Malta) Limited.
