CARMELO LUCA, 35 years, works in a betting company , son of Giuseppe and Carmela nee' Tricomi, born in Catania, Italy on the 10th July 1978 and residing at Number 42, Spinola Court, Upper Gardens, Swieqi and holder of Italian identity card bearing number AS 8974360;

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **Carmelo Luca** and prohibits the said accused from transferring or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the said accused may continue to receive an amount which will not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year.
