**MALCOLM (MALCOLM-JOSEPH) FALZON**, 44 years, company director, son of Spiridione and Rita nee' Brincat, born in Sliema on the 7<sup>th</sup> March 1969 and residing at Room Number 15, Sensi Hotel, Il-Maħsel Street, Marsascala and holder of identity card bearing number 0116569M;

**ORDERED** the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **Malcolm (Malcolm-Joseph) Falzon** and prohibits the said accused from transferring or otherwise disposing of any movable or immovable property and this according to Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.

The Court ordered that the said accused may continue to receive an amount which will not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year.
