**ACCEDED** to the request of **Michael Sciberras** in the sense that the Court authorized the accused to continue receiving his salary from Malta Freeport Corporation, which salary is received by the accused in his Bank of Valletta plc bank account bearing number 12000721021. Such amount cannot exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year in terms of Article 5(1)(a) of Chapter 373 of the Laws of Malta.

**ACCEDED** to the request of **Amabile Grech** in the sense that the Court authorized the accused to continue receiving his salary from Director General (Customs), which salary is received by the accused in his Banif Bank Malta plc bank account bearing number 168980.10.001. Such amount cannot exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year in terms of Article 5(1)(a) of Chapter 373 of the Laws of Malta.

The publication of this order is being published in terms of Article 23A, Chapter 9 of the Laws of Malta, following another publication made on the 25<sup>th</sup> February 2014 after a decree dated 16<sup>th</sup> February 2014 of the Court of Magistrates (Malta) as a Court of Criminal Inquiry where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to **Michael Sciberras, Amabile sive Bill Grech and Rokku sive Rocky Agius.**
