

IT IS BEING NOTIFIED that by a decree dated 16th July 2014 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Miriam Hayman LL.D) after an application filed by Brian Godfrey Bartolo on the 25th June 2014, Compilation number 51/2014 in the case:

Versus:

BRIAN GODFREY BARTOLO, 41 years, Self Employed, son of John and Carmen nee' Cilia, born in Pietà, on the 30th August 1972 and residing at Residential Court, Flat 15, Pioneer Road, Bugibba and holder of identity card bearing number 372972(M);

ACCEDED to the request of Brian Godfrey Bartolo, in the sense that the Court authorized the accused to open only one other bank account so that the Children's Allowance of his daughter and any income from his work as a self employed of Handyman Services Limited can be deposited into the same, so it is from this account that only the permissible annual sum of thirteen thousand nine hundred seventy six Euro and twenty four cents (€13,976.24) can be withdrawn.

The publication of this order is being published in terms of Section 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta, and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta, This follows a publication made on the 15th July 2014 after a decree by the same court on the 25th June 2014, following another publication made on the 21st January 2014 after a decree of the same Court on the 13th January 2014, where the Court ordered the attachment in the hands of third parties in a general manner, all monies and other movable and immovable property which may be due to or belonging to Brian Godfrey Bartolo.
